

Terms and Conditions

1 General

The general terms and conditions apply to all contracts, deliveries and other services. Any provisions of the contractor, I contradict explicitly. Any additional agreements require written confirmation on my part. "Irlbacher electronics" may at any time, including any annexes with reasonable notice to change these terms and conditions or supplement. Detailed orders are processed according to the old General Terms and Conditions.

2 offer

Our offers are non-binding. Small deviations and technical changes to our illustrations or descriptions are possible. The current catalog is invalid with the publication of a new edition.

3 Delivery and payment

The delivery and payment of "Irlbacher electronics" are shown in the order form. There is no minimum order quantity. All prices include VAT of 19%. It left to me to make a partial delivery, if this is advantageous for a speedy settlement. Desired by our customers special delivery will be charged with local supplement.

4 delivery Times

Goods that are in stock (for transport problems, we are not liable) will be shipped within 5 days for shipping. If not in stock when ordering the goods, we will try to deliver as soon. If non-compliance with a delivery or period of performance is due to force majeure, labor disputes, unforeseen obstacles or other circumstances we are not responsible, the deadline will be extended. Failure to comply with the delivery period for reasons other than the above reasons, the buyer is entitled to put in writing a reasonable grace period with penalty and after the unsuccessful expiration of the delivery or performance of the contract from the contract. Is the inability of supply to inability of the manufacturer or our supplier, so both we and the buyer of the contract may withdraw if the agreed delivery date by more than 2 months has been exceeded. Claims for damages because of delay or inability or failure to comply, including those that are incurred up to the cancellation of the contract, are excluded. Unless a legal representative of the company has acted "Irlbacher electronics" intentionally or with gross negligence

Conditions

5 Withdrawal and Follow

You can revoke your contract declaration within one month without giving reasons in writing (eg letter, fax, e-mail) or by returning the goods. The period begins with receipt of this instruction. The revocation period is sufficient to send the revocation or thing. The revocation must be sent to:

consequences of revocation

In case of an effective cancellation the mutually received benefits are to be returned and any benefits (eg interest) surrendered. Can you give us the performance received whole or in part, or return them in a deteriorated condition, you must pay us compensation for the value. With the release of things this does not apply if the deterioration of the goods on the test - it - as it would have been about you at our store. In addition, you can avoid the obligation to pay compensation by not using the goods as your property and omitting everything, which impairs their value.

Transportable items are to be returned . Not parcel things do you pick . You have to bear the cost of returning the goods if the delivered goods ordered corresponds and if the price of the returned goods does not exceed an amount of 40 euros or if you are at a higher price the thing at the time of the revocation yet the return or a contractually have produced agreed partial payment . Obligations to reimburse payments must be fulfilled within 30 days after its cancellation .

Special notes Your right of cancellation expires prematurely if your contractor has started to carry out the service with your explicit consent before the end of the revocation period or you yourself have caused this (eg by downloading etc)

End of cancellation policy
